1. I hereby agree to breed the mentioned above mare to the stallion for the _____ breeding season and to pay you the sum of \$ _____, plus board and expenses.
Plus this amount, a nonrefundable booking fee of \$ _____ is payable with this contract, and the balance of \$ _____ Plus all unpaid board and expenses will be paid when my mare is picked up. No re-breeding privileges will be honored unless these conditions are met.
2. You also agree to diligently try to settle my mare. Should I take my mare home before you have ample opportunity to settle her (having bred through _____ () heat period(s) or being certified in foal by _____ owners' veterinarian), then all unpaid board, expenses and breeding fees become due and payable.
3. The Mares and Foals will be carefully supervised and afforded the best possible care. However, I understand that Kamrowski's Painted Pastures, It's owners or agents will not be held responsible for accidents, sickness, or death to Mare or Foal, and they will exercise their own judgement in caring for them. I agree to accept full responsibility for any Veterinary or Farrier expenses incurred by my Mare or Foal.
4. Mares that are not halter broke will not be accepted. Mares shod in the rear will have their shoes removed
5. It is also agreed that if my foal does not stand and suck, or is a solid not including minimal white by APHA registration regulations, I will be entitled to a free breeding the same year only, and only to the same mare. This agreement will only apply if you are notified within one week from death; This notice to be accompanied by a statement from a licensed Veterinarian. If the mare proves not to be in foal in the year bred, or loses her foal, the stallion owner has the option to re-breed the same mare the same year. However, if the Mare is to be bred and owner fails to deliver her for the same breeding season, then any and all fees paid shall not be refunded and the contract is thereby cancelled.
6. A current Coggins test and health certificate, a Veterinarian statement that the vaginal area is free from infection, plus a statement showing the mare is breeding sound, and a copy of the mare's registration papers are required with each mare.
7. If for some reason the stallion named in this contract dies or becomes unfit for breeding, this contract shall become void.
8. A statement will be sent at the end of each month showing the balance due.
9. A breeders certificate will be mailed at the end of the notification of a live foal providing all outstanding bills are paid in full.
10. All Mares bred to said stallion must have rhinopneumonitis vaccine (Pneumabort-K+1b killed virus) shots at 3, 5, 7, and 9 months. Proof of vaccination will be necessary if mare aborts to receive re-breeding.
